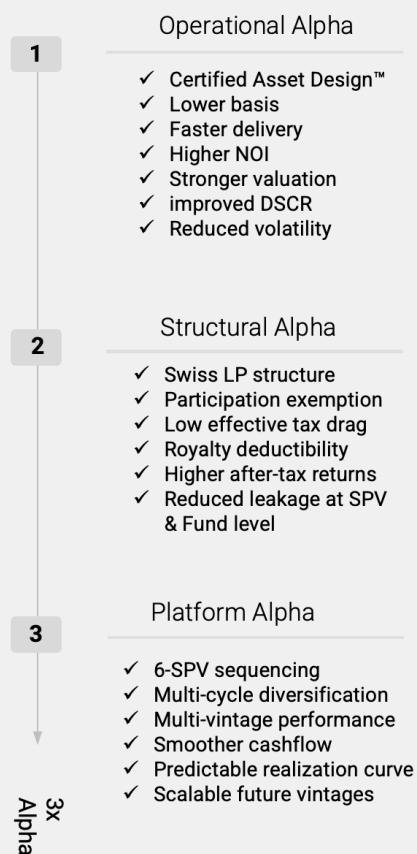
## Executive Summary

**ICON | RaR Alpha Fund** is a Swiss-domiciled, vertically integrated wealth platform that converts institutional real estate development into a governed, tax-efficient, repeatable performance engine. The platform unifies capital, Certified Asset Design™, execution certainty, targeted market positioning, and lifecycle asset management into a single system that consistently produces structural IRR uplift (+8–15%), enhanced DSCR stability, and superior downside protection.

Swiss governance, capital custody, and ICON's licensed royalty architecture create a highly efficient global structure in which qualifying gains benefit from Switzerland's participation exemption and low effective taxation. Project-level royalties are deductible at the SPV level and accretive at the GP level, reducing leakage while enhancing after-tax returns — all within a fully compliant Swiss and international legal framework.

ICON is not a traditional development fund. It is an institutional-grade, multi-project performance engine engineered to deliver repeatable alpha through disciplined execution, standardized delivery, and governed cashflow management.

A Swiss-structured, vertically integrated wealth platform engineered to deliver tax-efficient, risk-adjusted alpha through institutional real estate development.

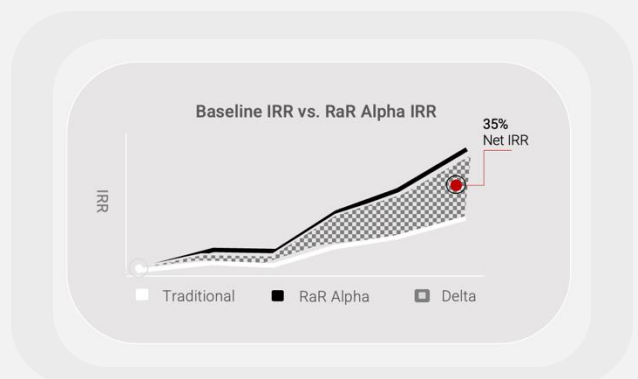

## Iconic Strategy

For decades, real estate development has been defined by fragmentation. Planning, design, construction, capital, and operations have evolved as separate disciplines — coordinated loosely, optimized independently, and managed reactively. Risk has been absorbed through buffers and contingencies rather than eliminated through system design. Sustainability, data intelligence, and human experience have been layered on late, often increasing cost and complexity instead of improving outcomes.

That model persists not because it performs well, but because replacing it has historically been impractical. Today, that constraint no longer exists.

Advances in certified design systems, modular manufacturing, lifecycle modeling, and governed capital architecture have fundamentally changed what is possible. Assets can now be planned, delivered, and operated as integrated systems — where performance, resilience, sustainability, and experience are designed in from the outset rather than negotiated later. Execution can be standardized without sacrificing market responsiveness. Sustainability can be achieved without premiums. Human-centered environments can be created without operational trade-offs.

ICON was built specifically for this modern reality. The platform integrates planning, design, delivery, capital deployment, and lifecycle management into a single, disciplined operating system. This allows assets to be conceived holistically, constructed with precision, and managed with foresight — producing environments that are intuitive to inhabit, resilient to operate, and aligned with long-term urban and social contexts.

Rather than treating capital efficiency, sustainability, execution certainty, stakeholder alignment, and lived experience as competing priorities, ICON treats them as interconnected performance inputs — intentionally designed to reinforce one another. Risk is addressed structurally, not reactively. Variance is reduced before capital is deployed. Performance is engineered, not hoped for. What emerges is not a collection of projects, but a platform philosophy — one capable of operating across markets, cycles, and delivery pathways while maintaining consistency of outcome. A system that elevates both the quality of the built environment and the durability of the investment behind it.

This strategic foundation is what makes ICON's performance possible. The sections that follow show how this philosophy is converted into measurable, repeatable investment outcomes at scale.



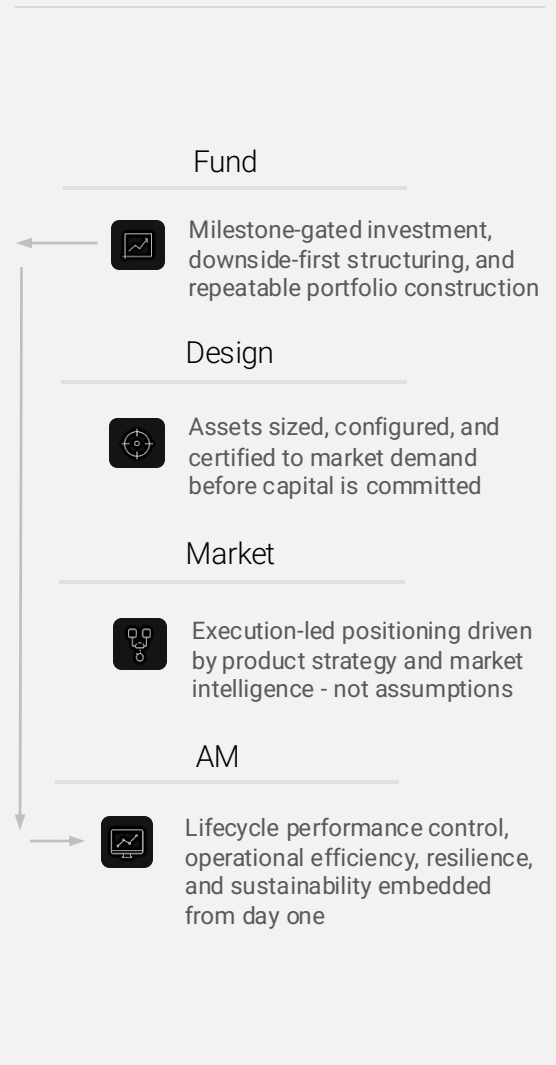
## Why Now?

The U.S. is entering a decade of chronic undersupply, tightening regulations, rising operating costs, and expanding ESG/sustainability performance mandates — conditions that heavily favor governed, execution-capable, design-led platforms over traditional developers. At the same time, lender retrenchment and capital scarcity have widened the spread between yield-on-cost and stabilized values, creating asymmetric opportunity for groups that can execute consistently.

### ICON is engineered specifically for this environment.


Certified Asset Design™, modular predictability, standardized underwriting, and milestone-gated capital deployment allow real estate to be planned, capitalized, and delivered as a repeatable, risk-controlled system rather than a series of bespoke projects. Swiss fund governance, a tax-efficient structure, and a proprietary royalty architecture further enhance after-tax outcomes while reducing leakage at both the fund and SPV levels.

Unlike traditional developers or capital strategies tied to market timing, ICON's execution model is market-agnostic and geography-agnostic — designed to operate wherever demand structurally exceeds supply. Standardized delivery, governed underwriting, lifecycle performance management, and disciplined exit optionality can be replicated across markets and vintages, creating a scalable advantage precisely as the industry enters its most constrained and opportunity-rich cycle in a generation.

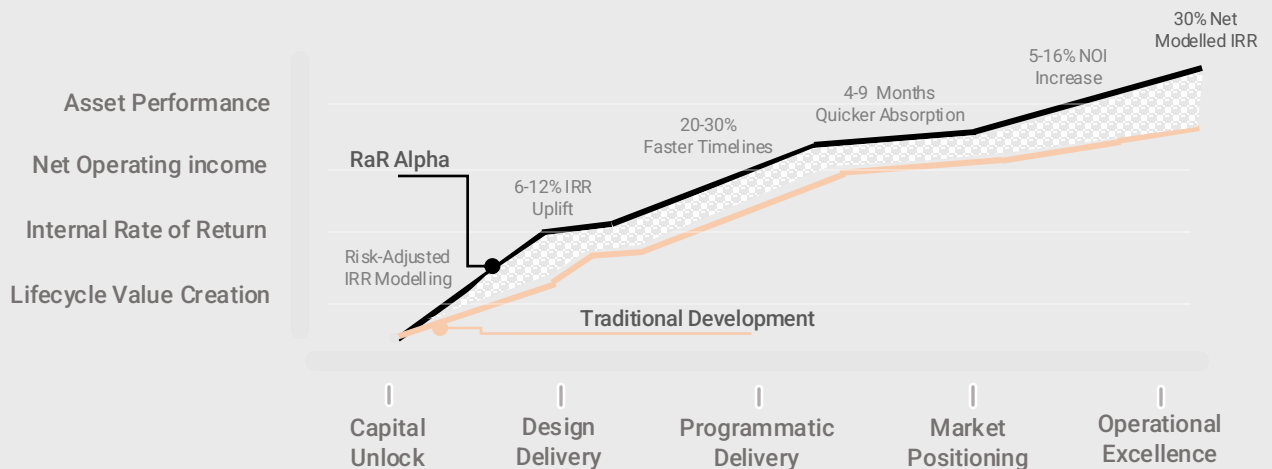


## Why ICON Outperforms

The result is a system where assets perform predictably, portfolios stabilize earlier and returns emerge from disciplined execution — not market speculation.

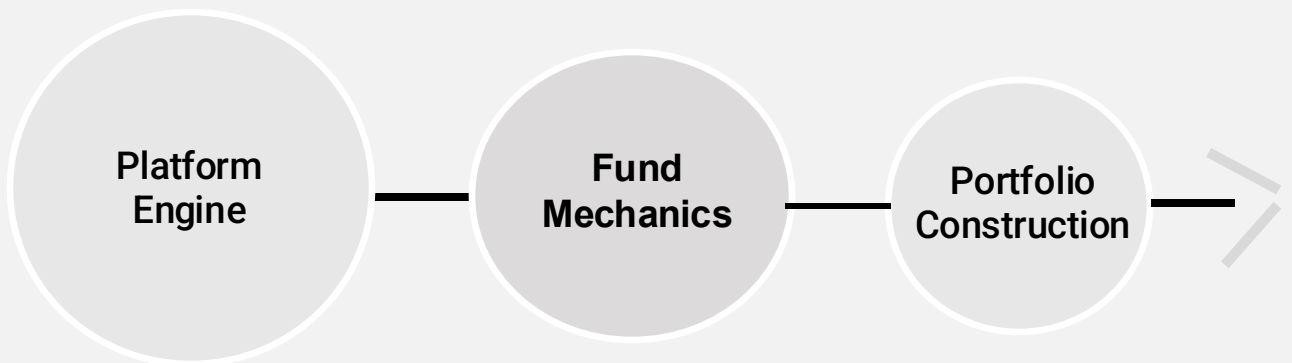

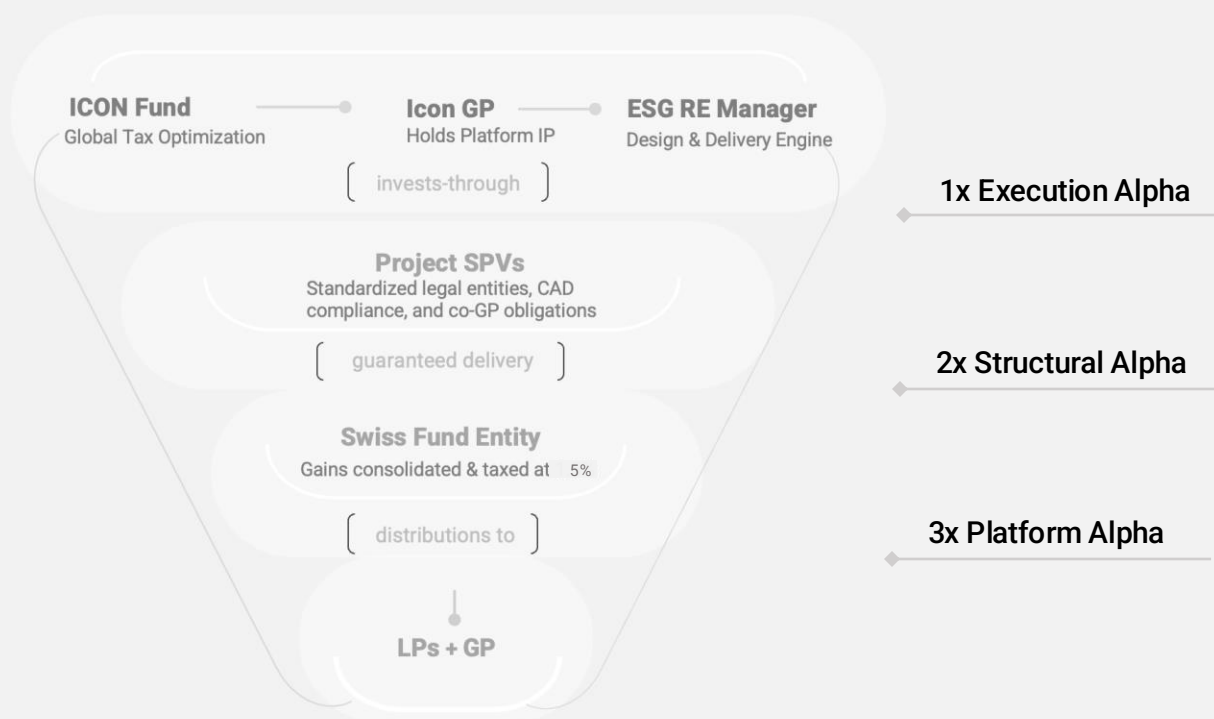

## Structural Fund Mechanics

ICON | RaR ALPHA is a Swiss-domiciled investment-wealth and capital-preservation fund designed for governed, sustainable, and repeatable outperformance. Its architecture is fully constructed — combining Swiss capital custody, GP–SPV framework, standardized legal instruments, and a sustainability-embedded execution model that exceeds global environmental and social benchmarks while delivering fully decarbonized, future-proofed assets. Capital flows through pre-structured SPVs with enforceable delivery controls, CAD™ compliance, modular execution pathways, and milestone-gated deployment. Returns consolidate into the Swiss fund entity where participation exemption and royalty deductibility support an efficient after-tax structure of 5%. The fund is intentionally designed to prioritize early capital recovery, portfolio diversification, and governed deployment before optimizing for upside.

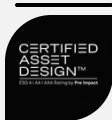

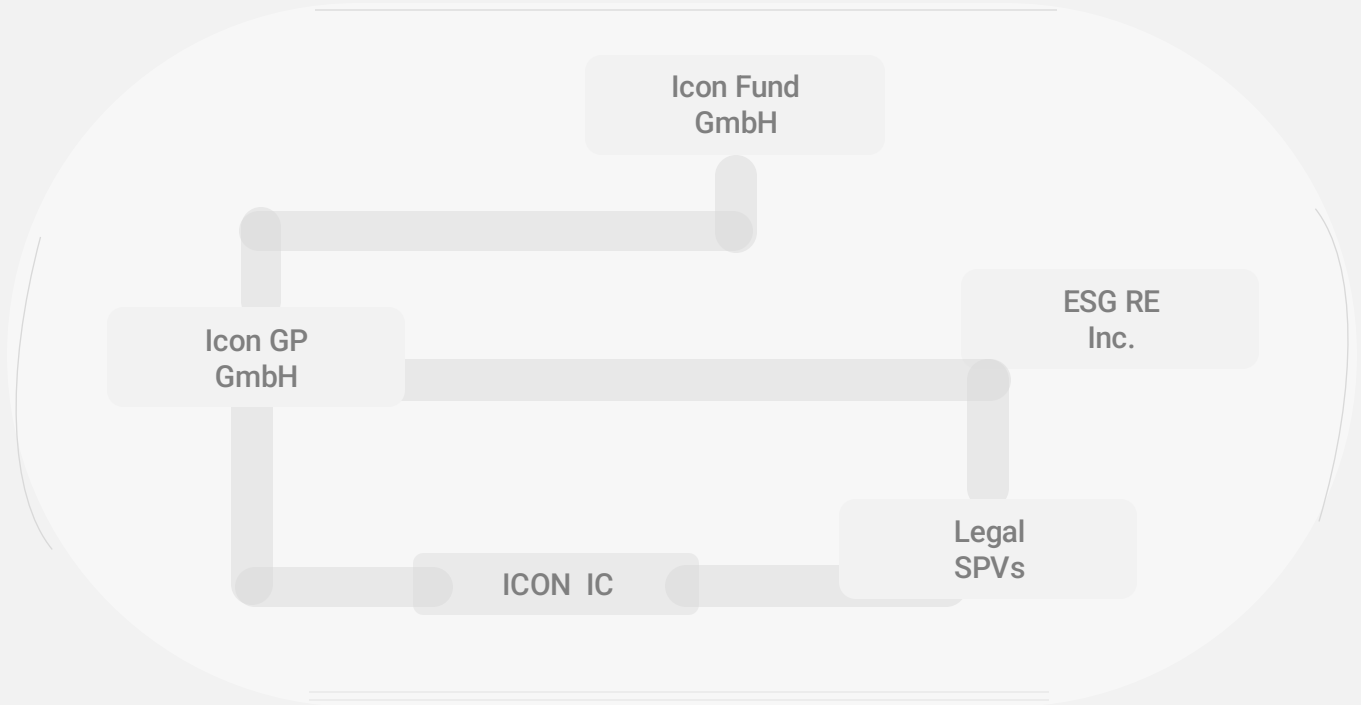

## Diversification Logic

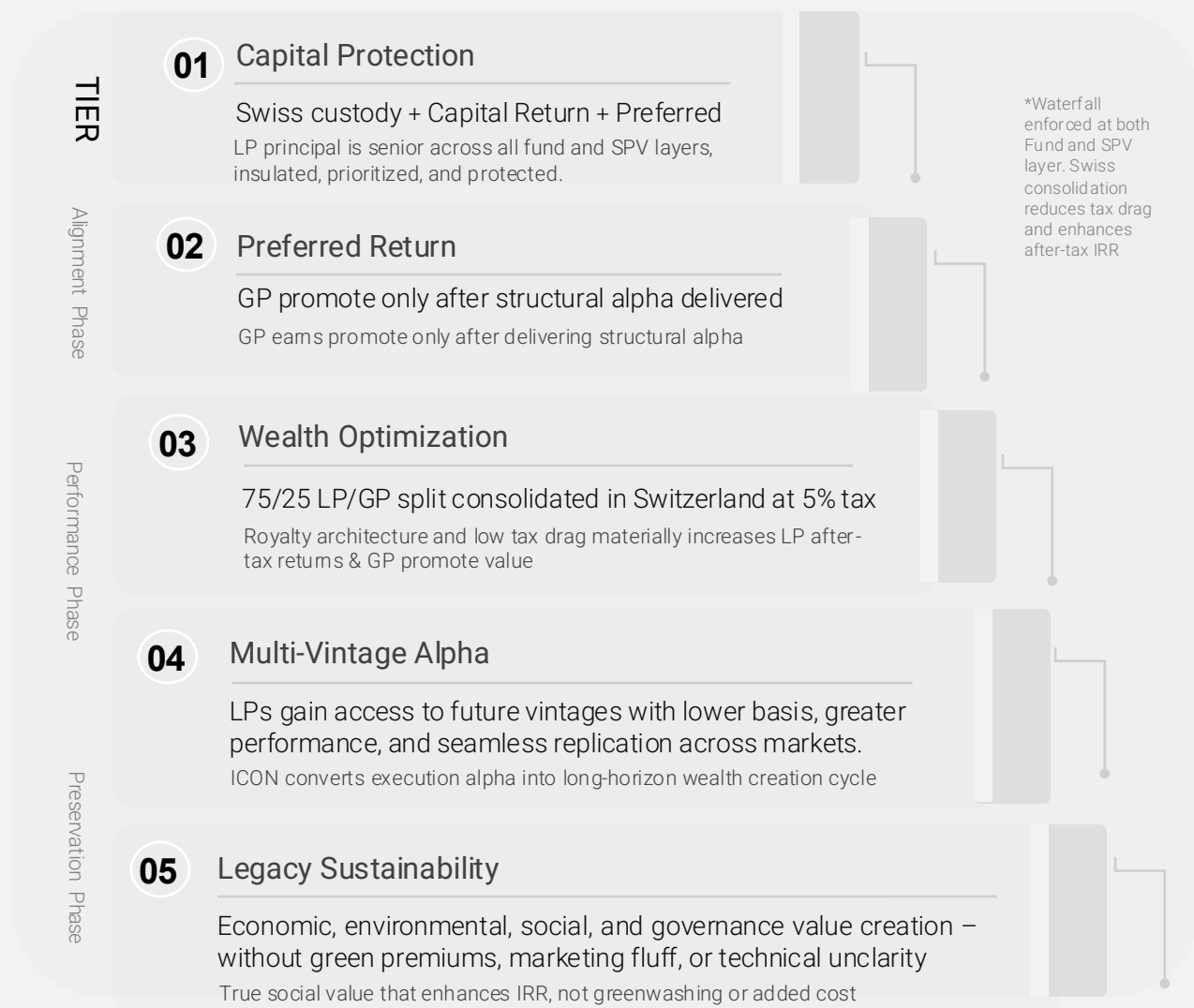

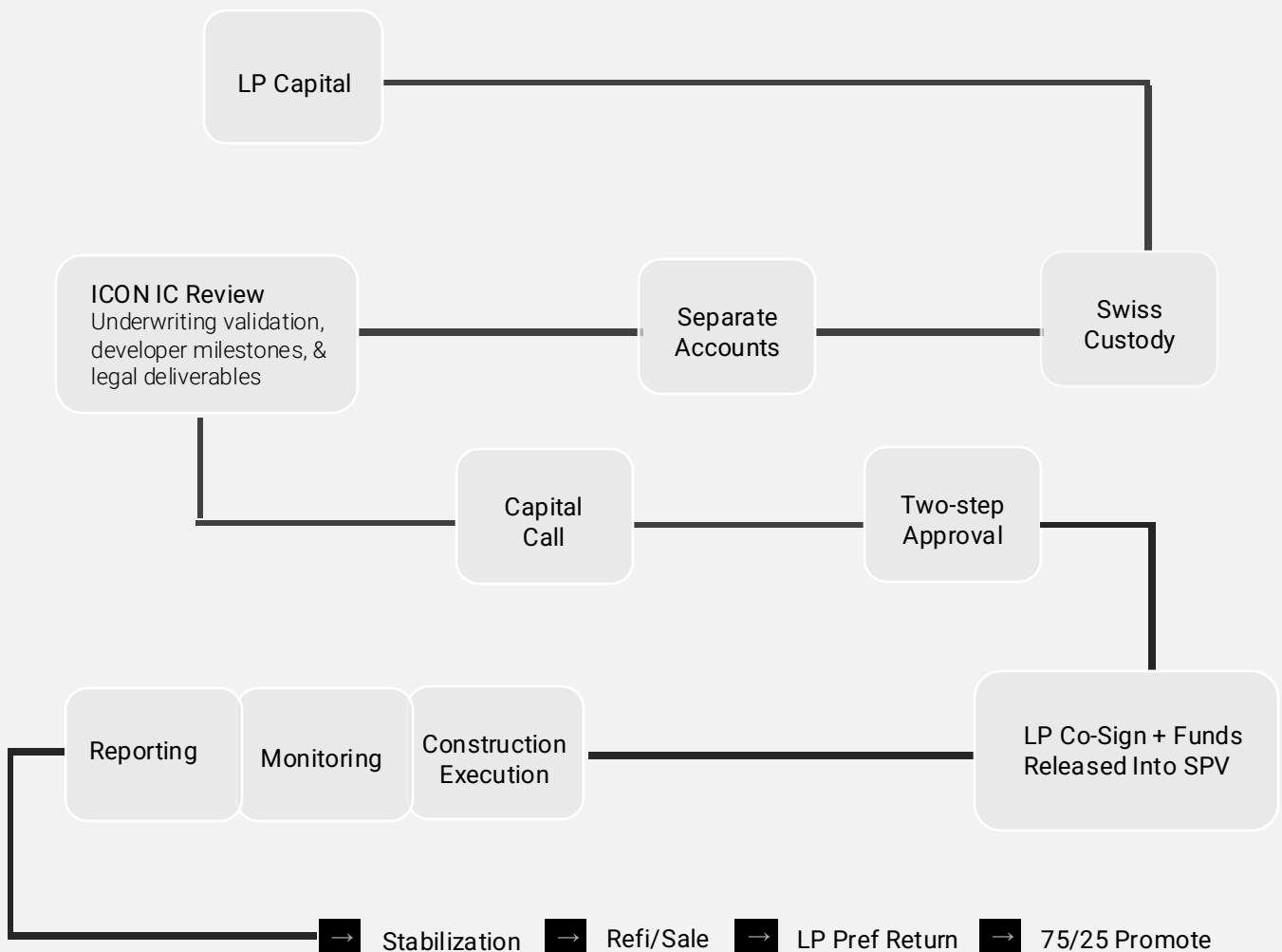

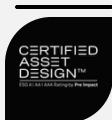

## Capital Call Protocol

Governed, multi-step capital release that protects LP capital, enforces underwriting integrity, and eliminates leakage.





## Fee Outline

A transparent, alignment-first fee architecture designed to protect LP capital, eliminate fee leakage, and ensure the GP is rewarded only for realized performance — not asset accumulation.

### Fund Management Fee

0.9%–1.5% per annum on committed or invested capital. No double-charging at the SPV level.

### Administrative Expenses

One-time fund formation + structuring expenses (capped and disclosed).

### Development & AM Management Fee

2%–4.5% of eligible project costs (hard + soft), paid by SPV, not the fund.

### Promote Structure – Performance Compensation

Promote activates only after LP capital & full preferred return are delivered. A tiered 75/25 at baseline IRR, stepping to 70/30 only upon higher realized IRR thresholds. No GP participation without measurable platform value.

### Transaction, Debt, & Disposition Fees

No acquisition fees. No disposition fees. Debt arrangement fees borne by lender or credited against GP promote if paid via SPV.

ICON's engineered capital stack systematically increases equity efficiency, enhances lender certainty, compresses development timelines, and strengthens stabilized valuations. The result is a lighter, more resilient, tax-optimized structure built for risk-adjusted outperformance.
